## TRIA ENDORSEMENTS REVISED IN VIRGINIA

**BACKGROUND** The Terrorism Risk Insurance Extension Act of 2005 extended the federal terrorism insurance mechanism through 2007.

**MSO<sup>®</sup> ACTION** We filed revised terrorism endorsements for Commercial Liability, Commercial Property, Businessowners, and Commercial Inland Marine in Virginia to conform with TRIEA. The revised endorsements build in the pre-TRIA exclusion provisions if TRIA ends on December 31, 2007.

**EFFECTIVE DATE** October 1, 2006.
