



## REVISED COMMERCIAL INLAND MARINE POLICY AND ENDORSEMENTS APPROVED DE & MD

# **BACKGROUND** We have updated the Commercial Inland Marine Policy MIM 010 to build in the Virus Contamination Exclusion as well as other revisions.

PROGRAM CHANGES This revision introduces a new version of the commercial inland marine policy MIM 010. The new 06 07 edition replaces the 12 96 edition.

The revision highlights include the following:

### INLAND MARINE COMMON PROVISIONS FORM - MIM 010 Exclusions / Losses Not Insured

Wear, Tear and Other Specified Loss / Cause of Loss Exclusions updated to include "raccoons". Add the Virus Contamination Exclusion from endorsement MCP 401.

#### **Loss Conditions**

How Losses Are Settled updated to recovery limitations or special limits condition to track with other MSO Commercial Property policies.

### **Common Conditions**

Added "the District of Columbia" to the Coverage Territory.

#### Glossary

Added definitions for "Fungi" and "Rot and Decay Organisms." Updated the definition of "You/Your/Yourself" to define named insured.

#### ADDITIONAL CHANGES

Format revised to remove the bullet characters and replace with alpha or numerical characters. Also removed parenthesis around letters or numbers.

The words "above" or "below" used when referencing other text in the policy has been revised to say "in the preceding paragraph" or "in the following paragraph". This change is being made as companies may reproduce the policies from their systems and due to different spacing, margins, etc., the items referred to may not always fall "above" or "below."
